## HIPAA Compliance with AdminDroid



The **Health Insurance Portability and Accountability Act** was brought into effect in 1996 by Congress. It is a set of standards that essentially aim to protect **PHI** (Protected Health Information) by regulating Health Care Providers.


HIPAA was effectively enforced though, only after the passage of the **Health Information Technology for Economic and Clinical Health Act** (HITECH). It solidified the **HIPAA** Act after it was brought into effect in 2009. The Omnibus Rule of 2013 further strengthened HITECH by issuing more precise requirements and clarifications to the HIPAA Privacy, Security and Enforcement Rules.

HIPAA covered entities are required to implement internal processes and controls to secure and protect PHI from tampering. An audit usually inspects these aspects to verify their effectiveness. The **HIPAA** Security Rule deals with information systems in health-care systems.

### CONTROL GROUPS

The whole process of IT Compliance to various regulations involves an organization developing and implementing controls that address the various facets of Information Technology. We have identified controls that **AdminDroid** can help with in implementation and grouped those controls under **Control Groups**, listed below, for management simplicity. 
